Commitment and results

Governance and People

Sustainability has impregnated the DNA of Alannia Resorts and we have focused on transmitting it with enthusiasm to our customers, suppliers and employees. Alannia Resorts is firmly committed to the 2030 Agenda and has opted for a responsible business model.

The Alannia Resorts Ethics Code was signed in 2020. The Ethics Codes is a code of conduct that sets out the guidelines that all managers, employees and collaborators of the company must follow in their daily work, in order to contribute with that effort to promote ethics in our business.

The Human and Labor Rights Policy is reviewed every year, where we promote fair and respectful practices, as well as our commitment to the protection of children. In addition, from April 2024, a Responsible Guest Guide is provided with every booking, encouraging our guests to notify the authorities (tel. 012) if they suspect any act of child abuse or exploitation. Both documents are published on www.alannia.com and staff are given training.

At the end of 2022, we signed the Diversity Charter, making visible our commitment to diversity and inclusion in the workplace. Daily, we work to build a diverse staff, promote an inclusive culture, promote personal and work-life balance policies.

In December 2023, the Equality Plan was signed, committing to maintaining and developing a work environment in which diversity is welcomed and valued, and to promoting equality of opportunity.

Sustainability Advances 2023

Environment

Alannia Resorts is continuously working to improve the impact we have on the people and areas of action. This commitment to constant improvement has led us to develop a data management and analysis program specifically designed for our resorts (APP CO2).

Among the objectives for 2023 we had to achieve the Miteco "Calculo Huella de Carbono" seal for all our resorts. We are pleased to inform that we have certified all our resorts, in addition, in Alannia Guardamar and Alannia Costa Blanca we have achieved the "Reduzco Huella de Carbono" seal, which is calculated by comparing the results of the year 2023 with an average of the years 2022, 2021 and 2020.

As from 2022, we are committed to reduce greenhouse gas emissions. Our results as at 31 st December 2023 were as follows:

Despite of not achieving our overall carbon footprint reduction goal, we have achieved it in the ACD and AS resorts. Our resorts AG and ACB dispute annually for the most sustainable position among our resorts in terms of carbon footprint. In the case of the ACB resort, there has been a slightly decrease compared to the previous year. However, AG and AEP have both increased their carbon footprint due to the air condition repairs made, for which corrective measures have already been taken to use drop-in refrigerant gases with lower GWP (Global Warming Potential).

We have achieved a reduction in the company's electricity consumption, despite this being below the target established. AG and ACB have a Guaranteed of Origin (GO) supply of electricity, resulting in a zero carbon footprint in scope 2. In 2022, ACB's facilities were improved with the installation of photovoltaic (PV) panels for self consumption, which was followed in 2023 by AG and AEP. We actively encourage guests and employees to assist us in our consumption reduction policy, which is shown on screens installed in common areas and on informative signage in accommodations and sanitary blocks.

By the end of 2023, we obtained the Travelife certification in all our resorts, marking a turning point in our drive for improvement, extending our objectives to include biodiversity protection, reduced water consumption and increased community support activities.

This ambitious project has taken us to begin calculating the Carbon Footprint in Scope 3. To do so, we have considered as indirect emissions generated in the value chain of Alannia Resorts as a result of our activity: water consumption and waste treatment.

This year, 2024, we have declared war against the purchase of single-use plastic products, implementing measures such as the use of reusable glasses and the replacement of amenities in favor of more sustainable products.

In 2023, the solidarity collection of food and hygiene products was implemented in the Alannia Els Prats supermarket, with the collaboration of the Red Cross. Due to the good reception of the community project, during this 2024 it has been also implemented in the rest of the supermarkets of the chain (Alannia Guardamar and Alannia Costa Blanca), and it will be permanently maintained. We encourage you to collaborate with those who need it the most.
